FUNCTIONAL BEVERAGE POWDER BLEND

A specialised ingredient blend intended for use in gut health-focused functional beverage recipes. With Inulin, Acacia Fibre, Reishi, and Turkey Tail, DIGESTRA-A delivers the ingredients commonly sought in products positioned for digestive support, nourishment of beneficial gut bacteria, and immune health.

Functional Focus

A dry, powdered functional blend designed to support gut-focused formulations through a combination of prebiotic fibres and mushroom extracts. Inulin and acacia fibre provide a source of fermentable fibre, while turkey tail and reishi contribute to polysaccharide-rich components commonly used in digestive wellness products.

Product Use

DIGESTRA-A is designed for versatility across a wide range of beverage applications. This blend has a largely neutral flavour profile, allowing it to integrate easily into functional drink formulations based on fruit juices and juice drinks, flavoured carbonated beverages, sports drinks, teas, coffees, and low to no alcohol beverages. The blend dissolves readily in water and confers a light, natural brown hue to beverages.

DIGESTRA-A is supplied in 0.5, 1.125, or 3.0kg HDPE tubs. Containers meet all food industry packaging regulations.
