A specialised ingredient blend intended for use in energy-focused functional beverage recipes. With Guarana, L-Theanine, Rhodiola Rosea, and Acetyl L-Carnitine, ENERON-A delivers the ingredients commonly sought in products positioned for increased alertness, reduced fatigue, and improved focus and physical performance.

Functional Focus

A dry, powdered functional blend designed to deliver smooth, sustained energy, this blend pairs naturally sourced caffeine from guarana with adaptogenic botanicals and functional amino compounds. Rhodiola rosea supports resilience and performance, while L-theanine helps promote a more balanced energy profile alongside acetyl-L-carnitine for mental clarity and focus.

Product Use

ENERON-A is designed for versatility across a wide range of beverage applications. This blend has a slight herbal flavour profile, allowing it to integrate easily into functional drink formulations based on fruit juices and juice drinks, smoothies, flavoured carbonated beverages, sports drinks, herbal teas, and coffees. ENERON-A dissolves readily in water and confers a light, golden-orange hue to beverages.

pH Tolerance: Recommended final product pH of 3.5-4.5 for optimum stability of bioactive compounds.

Pasteurization: The blend is compatible with typical beverage pasteurization processes. The heating process may affect the bioactive compounds within product; however, extent is variable depending on methodology.



Blending method: Product should be added pre-carbonation to avoid foaming. To maintain quality of bioactive compounds, adding post-fermentation, pre-carbonation and pasteurization is preferred. However, can be added hot side if pasteurization is not available.

ENERON-A is supplied in 0.5, 1.125, or 3.0kg HDPE tubs. Containers meet all food industry packaging regulations.

Storage

When stored in a cool, dry place away from direct sunlight and moisture, the shelf-life is 18 months from the manufacture date. Once opened, reseal tightly and use within 30 days.
