FUNCTIONAL BEVERAGE POWDER BLEND

A specialised ingredient blend intended for use in immune support-focused functional beverage recipes. With Turkey Tail, Ginger, Vitamin C, and Zinc Gluconate, IMMUNIQ-A delivers the ingredients commonly sought in products positioned for immune system support and antioxidant protection.

Functional Focus

A dry, powdered functional blend designed to support immune-focused beverage formulations. Turkey tail mushroom and ginger extracts are paired with Vitamin C and Zinc, nutrients widely used in immune-support beverage formulations.

Product Use

IMMUNIQ-A is designed for versatility across a wide range of beverage applications. This blend has a largely neutral flavour profile with a subtle hint of ginger, allowing it to integrate easily into functional drink formulations based on fruit juices and juice drinks, flavoured carbonated beverages, sports drinks, teas, coffees, and low-to-no alcohol beverages. IMMUNIQ-A dissolves readily in water and confers a natural light brown hue to beverages.

Packaging

IMMUNIQ-A is supplied in 0.5, 1.125, or 3.0kg HDPE tubs. Containers meet all food industry packaging regulations.
